Once the admission file is complete (all files have been received), the file will be sent to the selection committee for review and applicants will be contacted via official letter in the mail. It is the applicant's responsibility to turn in all needed items for the program application process. Failure to finish the application requirements will result in an incomplete application file and non-acceptance to the program.

Checklist for the School of Nuclear Medicine Technology:

*In addition to the basic requirements to apply to the NMT program, the following documents/qualifications must be met to be reviewed for acceptance.

Application on file for the calendar year

Official high school transcripts/GED certification

- Contact the high school attended to obtain official transcripts. If the applicant's high school is no longer in service, contact the Arkansas Department of Education. To obtain official GED scores, contact the Arkansas Department of Education.

Official ACT/SAT scores.

- BHCLR offers the ACT on our campus as a residual testing site. To register for the ACT visit bhclr.edu, Prospective Students, then ACT Registration.

Official college/university transcripts

- BHCLR requires an official transcript for each college/university attended. The attended colleges/universities listed on your application will be assumed to be the only colleges/universities attended until the applicant file is sent for an academic audit. The academic audit will determine if all college/university transcripts have been received. Failure to list all colleges/universities attended may result in non-selection due to insufficient information given.
- Examples of official transcripts needed: high school, college, university, career school, professional school, nursing school, military school, post-secondary school, etc.

Personal Statement

- To obtain the personal statement form, visit bhclr.edu, Programs of Study, then Nuclear Medicine Technology under requirements.

Two recommendation forms

- To obtain the recommendation form, visit bhclr.edu, Programs of Study, then Nuclear Medicine Technology under requirements.
- Forward to an individual, not a relative, in a position to comment on your qualifications for entering a Baptist Health College Little Rock. Recommendations brought in by the applicant will not be accepted.

Financial Aid (optional)

- BHCLR Foundation Scholarships are available each semester to select BHCLR students. A new application is available online, in person with the Financial Aid office or by

- Important note: As an affiliate school student, all financial aid will be completed through the affiliate university. Students at BHCLR are still eligible for BHCLR Foundation Scholarships.
